3. Should you cancel 50% cancellation fee required of balance if Cancelled less than 6 weeks prior then full balance must be paid 75% will be refunded should another booking take its place.
4. If you have booked the full highland uniform this cannot be guaranteed due to weather or other unforeseen circumstances.
5. The function stated is more than 45 minutes late then the piper has the right to charge an additional charge of £75.00
6. If the unlikely event I am unable to attend due to other work commitments or illness then I will supply a piper of similar standard (though uniform cannot be guaranteed) I will inform you ASAP.
